Orders and Payment options

All orders will only be processed when made with full payment.

Payment for orders by Internet should be made using Credit Cards.

Please note that our ability to satisfy your order is subject to the availability of our stocks, or the stocks of our suppliers.

Delivery

Goods will ordinarily be sent out by Courier unless advised at the time of placing your order.

Prices for overseas delivery will be quoted when ordering, including courier charges.

Force Majeure

Bahrain International Circuit Company will not be liable for any failure to perform any of its obligations if the delay or failure is caused by circumstances beyond our control. Without prejudice to the above the following shall be regarded as beyond our control:

Satisfaction Guarantee

It is our policy that if you are you not completely satisfied with a product within 7 days of receipt, you can return the goods in their original packaging, including literature, in as new condition. We only ask that the goods must be unused and in their original packaging, with your proof of purchase.

No goods should be returned without authorization from Bahrain International Circuit Company. Claims for goods damaged in transit must be made within 3 days of delivery. In the case of damaged items, always retain them for inspection by our representative or courier. None of these conditions affect your statutory rights.

Returns

No goods may be returned to the company without its express consent. In the event of faulty/damaged goods being received by the purchaser, please telephone + (973) 17 45000 during working hours to advise us of the problem, where upon arrangements will be made to rectify.

Claims for products shipped faulty or damaged must be made within 3 working days.

Back orders

We reserve the right to ship part orders, or hold orders until all items are available as required. We shall only levy one delivery charge. We reserve the right to cancel any part of an outstanding order should secure supply become untenable.

Cancelling an order
